Chudleigh Road, Exeter - Traffic Regulation & Speed Limit Order Proposals

Devon County Council propose to make these under the Road Traffic Regulation Act 1984 for Exminster and Exeter

Devon County Council (Chudleigh Road, Exeter) (Prohibition of Motor Vehicles) Order to introduce

• **Prohibition of Motor Vehicles** on Chudleigh Road from its junction with the A379 to a point 30 metres northwest of that junction

Devon County Council (Chudleigh Road, Exeter) (30mph Speed Limit and Restricted Road) Order to introduce

- **30mph** on Chudleigh Road from a point 22 metres north-west of its junction with Markham Lane to a point 281 metres north-west of its junction with A379
- 30mph by virtue of streetlighting (Restricted Road) on
 - Chudleigh Road from its junction with A379 to a point 281 metres north-west of that junction
 - Chudleigh Road Eastern Link Road for its entire length

For ease of reference existing restrictions are in the draft orders above

Devon County Council (Chudleigh Road, Exeter) (Prohibition of Heavy Goods Vehicles) Order to introduce

• **Prohibition of Heavy Goods Vehicles** on Chudleigh Road Eastern Spur from its junction with the A379 in a north westerly direction for 5 metres north westbound

Devon County Council (Chudleigh Road, Exeter) (No Waiting At Any Time) Amendment Order to introduce

No Waiting At Any Time on both sides of the entire length of Chudleigh Road Eastern Spur. Where appropriate
there will be the usual exemptions including those in relation to picking up/setting down passengers,
loading/unloading goods and disabled persons vehicles

Statement of Reasons

As part of the south-west Exeter developments a new road is to be constructed between Chudleigh Road and the A379, referred to as Chudleigh Road eastern spur. To facilitate this new road it is proposed to prohibit motor vehicles from using the existing Chudleigh Road junction with the A379, instead using the new eastern spur road. The existing heavy goods vehicles ban would relocate to the new junction. It is also proposed to amend the speed limit on Chudleigh Road to 30mph due to new street lighting in the area and to increase safety for drivers and pedestrians. No waiting at any time is proposed for the full length of the new spur road so that vehicle movements are not affected by parked cars.

Specifically, the restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, will facilitate the passage on the road of any class of traffic (including pedestrians) and will preserve or improve the amenities of the area through which the road runs.
