

**Devon County Council (Various Roads, Okehampton)  
(No Waiting At Any Time) Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, part IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers

- 1** This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Various Roads, Okehampton) (No Waiting At Any Time) Amendment Order \_\_\_\_\_”
- 2** The schedules in part 1 are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2024 as amended and the length of road in part 2 is revoked from the corresponding schedule of that order

**PART 1            RESTRICTIONS**

**Schedule 1.001            No Waiting At Any Time**

**Dartmoor View, Okehampton**

- (i) both sides for its entire length including its southeastern spur

**Hameldown Business Park, Exeter Road Industrial Estate, Okehampton**

- (i) both sides for its entire length including all sides of the roundabout

**Hameldown Road, Exeter Road Industrial Estate, Okehampton**

- (i) both sides for its entire length

**Higher Stockley Mead, Okehampton**

- (i) the east side for its entire length
- (ii) the west side from its junction with Road Past Fatherford Farm in a northerly direction for a distance of 43 metres
- (iii) the west side from its intersection with the northern building line of Unit 3 Higher Stockley Mead to its northern extent

**Higher Stockley Mead (Eastern Spur), Okehampton**

- (i) the north side for its entire length
- (ii) the south side from its junction with Higher Stockley Mead in an easterly direction for a distance of 20 metres

**Kellands Lane, Okehampton**

- (i) both sides from its junction with Road From Hameldown Business Park To Kellands Lane in a southerly direction for a distance of 17 metres

**Road From Hameldown Business Park To Kellands Lane, Okehampton**

- (i) the north-east side from its western extent approximately 24 metres west of its junction with Kellands Lane to its junction with Hameldown Business Park at the roundabout
- (ii) the south-west side from its junction with Hameldown Business Park at the roundabout to a point 67 metres south-east of its junction with Kellands Lane
- (iii) the south-west side from a point 37 metres south-east of its junction with Kellands Lane to its western extent approximately 24 metres west of its junction with Kellands Lane

**Road From Hameldown Business Park To Kellands Lane (North Eastern Spur), Okehampton**

- (i) both sides for its entire length

**Schedule 1.001 No Waiting At Any Time**

**Hameldown Road, Exeter Road Industrial Estate, Okehampton**

- (i) both sides from its junction with Beardown Road to its junction with the roundabout including all sides of the roundabout
