

**Devon County Council (Various Roads, North Molton)  
(30mph Speed Limit & Restricted Road) Order**

Devon County Council make this order in exercise of powers under sections 82, 83, 84, part IV of schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers

1. This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Various Roads, North Molton) (30mph Speed Limit & Restricted Road) Order”
2. No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 1
3. The lengths of road specified in schedule 2 are restricted roads for the purpose of section 81 of the Act
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
5. The order in schedule 3 is revoked

**Schedule 1 30mph Speed Limit**

*Lengths of roads in North Molton in the District of North Devon*

Road From Marsh Hall To Lower Poole Farm from a point 9 metres north of its junction with Roberts Field to a point 51 metres south of that junction

Lane From Holdridge Cross To South Holdridge from its junction with Lane From Holdridge Cross To South Holdridge to a point 36 metres south-east of that junction

Road From Cross Lane Cross To Corner Cottage from its junction with The Square to a point 153 metres north-west of that junction

East Street from a point 21 metres south-west of its junction with Road From High Bullen Cross To Kensall Cross to a point 207 metres south-west of that junction

Road From Stonybridge Cross To Oakford Cross from a point 10 metres north-west of its junction with Road From Oakford Cross To North Molton Cross to a point 31 metres north-west of that junction

**Schedule 2 Restricted Roads**

*Length of roads in North Molton in the District of North Devon*

Road From Oakford Cross To Borners Bridge from its junction with Road From Stonybridge Cross To Oakford Cross to a point 67 metres west of that junction

Road From Oakford Cross To North Molton Cross from its junction with Road From Stonybridge Cross To Oakford Cross to a point 125 metres east of that junction

Road From Stonybridge Cross To Oakford Cross from its junction with Road From Oakford Cross To North Molton Cross to a point 10 metres north-west of that junction
