

## Devon County Council (Various Streets, Devon) (Electric Vehicle Recharging Point Parking) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce in

### EXETER

**No Waiting At Any Time** on a specified length of Mallard Road; **Electric Vehicle Recharging Point At Any Time** on specified lengths of Barrack Road, Belmont Road, Blackall Road, Bonhay Road, Buddle Lane, Cowick Hill, Ferryman Way, Gladstone Road, Hamlin Lane, Hanover Road, Haven Road, Iddesleigh Road, Langaton Lane (Western Spur), Mallard Road, Pinhoe Road, Queen Street, St Leonards Road, Sydney Road and Whipton Lane; **Revocation of Electric Vehicle Recharging Point At Any Time** on a specified length of Albatross Road; **Revocation of Car Club Vehicles Only At Any Time** on specified lengths of Albatross Road, Barrack Road, Belmont Road, Blackall Road, Bonhay Road, Buddle Lane, Cowick Hill, Ferryman Way, Gladstone Road, Hamlin Lane, Hanover Road, Haven Road, Iddesleigh Road, Langaton Lane (Western Spur), Peppercombe Avenue, Pinhoe Road, Queen Street, St Leonards Road, Sydney Road and Whipton Lane

Residents, charity business occupier, supported living, school business, motorcycle, scooter and other vehicles band A permits (up to 100g/km) £35 annually, other vehicles bands B-K (101-225g/km) 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £55, 3<sup>rd</sup> permit £65; bands L-M (over 225g/km) 1<sup>st</sup> permit £35, extra permits £65; virtual visitor permit £30 per 200 hours for schemes not operating at all times/350 hours for schemes operating at all times allocated in 1 hour sessions, physical daily visitor £30 for 30 (24 hour) permits, business annual: 1<sup>st</sup> permit £35, 2<sup>nd</sup> permit £75, 3<sup>rd</sup> permit £150; annual trade £45, short stay trade £60 for 20, daily trade permit £5, weekly trade permit £25; guest house/hotel visitors £30 for 20 permits; essential visitor permit £10 annually, care worker permits are free

**Electric Vehicle Recharging Point At Any Time** on specified lengths of Den Crescent and Shute Hill; **Revocation of Car Club Vehicles Only At Any Time** on a specified length of Den Crescent

### TOPSHAM

**Electric Vehicle Recharging Point At Any Time/Revocation of Car Club Vehicles Only At Any Time** on a specified length of Holman Way

## **Statement of Reasons**

Following the collapse of Co Cars the Council is in the process of procuring a new car club provider. However, it has been recognised that the new provider will not currently be providing Electric Vehicles. It is therefore proposed to convert Car Club bays with electric charging points to Electric Vehicle Recharging Points, to maximise the available on street parking and charging locations available throughout Devon. The proposal will provide additional recharging bays for those who have access to electric vehicles by providing a clean safe alternative to the conventional engine, reducing the negative environmental impact and improving air quality. In addition, it is proposed to remove car club EV bays where the recharging point is to be removed and to adjust certain measurements in the Order so they correspond with existing on street road markings.

Specifically, the order if made will preserve or improve the amenities of the area through which the road runs.
